## **WAIVER, PHOTOGRAPHY CONSENT & RELEASE OF LIABILITY**

1. I acknowledge that: (a) In admitting my dog(s), Dogcity Daycare is relying solely on my representations that my dog(s) is in good health and has not harmed or shown aggressive or threatening behaviour towards any person, animal or thing, as answered on the enrolment document. I warrant that this information is correct and that I will inform Dogcity Daycare if this information changes; (b) Dogcity Daycare is a cage free environment with dogs housed together in a run and I accept that there are inherent risks associated with such an environment, including (but not limited to): (i) Transfer of communicable illness, such as kennel cough (ii) Injuries, including broken nails, abrasions, bites, cuts and sore pads; and (iii) Behavioural problems; (c) Although Dogcity Daycare carefully screens all applicants, occasionally it is discovered that this is not an appropriate environment for every dog. Dogcity Daycare retains the discretion to temporarily or permanently remove my dog(s) from the daycare at any time; (d) I have read and understood the 'Dogcity Daycare Waiver and Release of Liability' and the 'Dogcity Daycare Rules and Regulations.'

2. I agree that: (a) I am solely responsible for any loss, damage or harm caused or contributed by my dog(s) while it is attending daycare at Dogcity Daycare; (b) While my dog(s) is in the care and custody of Dogcity Daycare and in the case that I cannot be contacted and/or in the event of an emergency, Dogcity Daycare, its agents and/or representatives may seek immediate veterinary care for my dog. (c) I am responsible for all costs associated with clause 1(c) and clause 2(b), and will provide Dogcity Daycare with my credit card details so that it may be used for the payment of such costs; (d) I will abide by the rules set out in the 'Dogcity Daycare Waiver and Release of Liability' and the 'Dogcity Daycare Rules and Regulations,' accepting all terms, conditions and statements contained within.

3. I release Dogcity Daycare, and its employees and agents, from all liability, and indemnify Dogcity Daycare from any and all claims of every kind and nature whatsoever, arising directly and indirectly, from my dog(s) participation in activities or use of service, including any legal claims and medical expenses.

4. My dog(s) image may be photographed whilst in Dogcity Daycare for use on our public website or social networking site (Facebook and Instagram). Any media or other use of images will be notified to me and agreed to on a case by case basis.
